FUNDING PHILOSOPHY SHIFTS

Bold Goals

Three years of funding

Fully fund whenever possible

\$50,000 cap per program per year

\$3M in requests... \$750k to award

PROCESS

Grants reviewed by 66 volunteers

Scores could be changed

Full funding required a unanimous vote

Agency staff participated on panels they weren't conflicted with.

TIERS 1, 2 & 3

TOTAL score determined where in line the program fell

- Tier 1 Funding in the \$750k
- Tier 2 Funded based on campaign increase
- Tier 3 No funding

Then onto an agency financial review

30 programs funded in 21 agencies

LAST time 54 programs with 33 agencies

7 BRAND new agencies we've never funded


Tier 3 – No funding (Included 16 currently funded programs, 8 were very difficult conversations)






GEOGRAPHY COMPARISON







GEOGRAPHY TIERS 1 & 2







AGE DEMOGRAPHIC COMPARISON






AGE DEMOGRAPHICS TIERS 1 & 2
